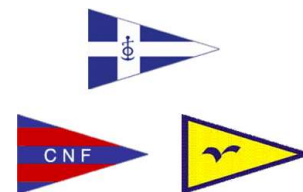

3. RULES:

- 3.1** The regatta will be governed by the Rules as defined in the WS 2017/2020 Rules of Sailing (RRS);
- 3.2** The "Rules for the National Sports Activity in Italy 2020" of the FIV are to be considered as a rule, as well as the FIV prescriptions to the RRS ;
- 3.3** [DP][NP] From the in force "Protocol of Regulation of the Measures for the Contrast and Containment of the diffusion of the Covid-19 in the Affiliated Sports Societies and Associations" of the Italian Sailing Federation: a breach of the "Protocol" may result in the application of a DP.
- 3.4** For Class RS:X the Appendix "B" of the RRS (competition rules for sailboards) will be applied with the modification that Appendix B8 will not be applied. Appendix "A.8" of the RRS will be applied for the resolution of parity.
- 3.5** In the event of a conflict between the NOR and the SI, the latter shall prevail (this changes RRS 63.7)
- 3.6** The Appendix "P" of the RRS (Special Procedures for Rule 42) will be applied;
- 3.7** The decisions of the Protest Committee will be appealable as for RRS 70.5(b);
- 3.8** For the Laser Radial F / J Class a carbon fiber lower part of the mast will not be allowed;
- 3.9** For the Formula Kite Class Appendix F of RRS shall be applied following the specific Class Rules: [http://www.sailing.org/tools/documents/FK2019CR20190318-\[24846\].pdf](http://www.sailing.org/tools/documents/FK2019CR20190318-[24846].pdf).
- 3.10** As regards iQFOiL Class Provisional Class Rules will be applied

4. PUBLICITY[DP] [NP]: Advertising is allowed according to World Sailing Regulation 20. Competitors may be required to display advertising chosen and provided by the organizing authority within the limits set by Regulation 20 of World Sailing. Italian competitors who display individual advertising will have to deliver the FIV license in force at the time of registration.

5. ENTRY: All boats of the Olympic Classes 470 M/F/Mixed, Laser Standard, Laser Radial Female, Finn, RS:X M/F, 49er, 49erfx , Nacra17 are eligible to participate. In Class 470 the participation of mixed crews will be admitted in experimental form.

Class 2.4, Hansa 303 and, experimentally, the Formula Kite and iQFOiL Classes will also be admitted. For Class 2.4mr and Hansa 303 all Italian helmsmen FIV registered and registered in the Class are allowed, also for Class 2.4 Mr the race is valid for the Guldmann Cup and Challenge Trophy "Mixed Inclusion Trophy".

For the Formula Kite Class a maximum of 40 participants will be allowed with priority registration for Italian competitors. Any entries of foreign competitors will be accepted in chronological order of registration until the maximum total number of 40 competitors.

The Championships are open this means for Italian, foreign or mixed crews (Italian and foreign). Foreign or mixed crews will not compete for the assignment of the title of Italian Champion and will not be included in the Results for the purposes of the award as from Point 4, Admission and Participation in the Sporting and/or Competitive Activities of the Rules for National Organized Sports Activities in Italy 2020.

6. Registrations:

Registrations (as per Point C.5 of the "PROTOCOL") shall only be made via the MyFedervela App or on the FIV website at: <https://iscrizionifiv.it/iscrizioni/index.html?r=24008> no later than 7 September 2020. By that date the crews will have to pay the relevant registration fee to the Organizing Committee by bank transfer to:

Foreign competitors shall register only via the FIV website at:

In the case of a single bank transfer for more than one boat, the Class and sail numbers of all boats should be stated.

Registration will be considered completed upon receipt of the email containing the self-certification form

attached to this notice, relating to the possession of all the necessary original documentation, at the following address: regate@gvlnifollonica.it, with the subject: "CICO2020; class... ..; no. sail"

For competitors under the age of 18, the self-certification form must be signed by a parent, guardian or support person who acts in accordance with rule 3.1 (b) and who, during the event, assumes the responsibility to allow him to race.

Random checks can be made by the OC, RC, Jury or Technical Committee.

Registrations made or received otherwise will not be accepted.

Those who have signed in via APP or website correctly and sent all the required documentation in a single email to the above address, will not have other documentation to submit. It will also not be necessary to sign the release form, acceptance privacy policy and assignment of photo and video rights of the event.

The FIV card can also be exhibited through the My Federvela App.

In case of non-participation the Registration Fee will not be returned.

For Class 2.4mr the registration fee includes the launching and towing of the boat.

As for Decision n. 59 on 24 april 2020: Operations in Support of Affiliated Associations and FIV members for Covid-19, 30% of the registration fee (€ 18.00 for single classes and € 24.00 for double classes) will be paid by the FIV which will correspond to the Organizing Committee.

Therefore, the registration fee shall be:

for single classes € 42.00,

for double classes € 56.00.

7. MEMBERSHIP: All competitors must be in compliance with the FIV Membership (including the medical examination visa). Moreover the competitors will have to be enrolled to the respective associations of Class recognized from the FIV.

Any foreign competitors must be in compliance with the requirements of their National Authority.

8. INSURANCE: The boats must be insured for civil liability for damages to third parties as provided for in point "D.1 INSURANCE" of the Rules for the National Sports Organized in Italy 2020, with a minimum ceiling of € 1,500,000,00 or alternatively, with FIV Plus card. The insurance policy or valid replacement document must be sent to the Secretariat of Regatta upon registration.

9. MEASUREMENT [DP] [NP]:

The crews admitted to the Championship will be able to submit to the preventive controls only equipments already measured and in the quantities previewed by the Class regulation.

All boats must race with the sail number as from their Class Rules. Any changes may be authorized by the Technical Committee only for breakage or damage after verification of the damage by the same Technical Committee or, in his absence from the C.d.R..

A boat or equipment can be checked at any time, to check the compliance with the Class rules, the Notice of Race or the SI. All boats after finishing in each race will have to pass between the finish boat and the boat of TC, if present, placed on the right side of the finishing line (see drawing in Appendix 1 of the SI). Modifications to the boat before inspection are not allowed.

Being on an experimental basis and in support of the participation, all materials are accepted even those not included in the documents of the registered products IKA.

For the Formula Kite Class the rules of equipment declared are in place:, a maximum number of 4 (four) wings in sizes as per the Formula Kite class rules without necessarily having to be registered, one Hydrofoil column.

If the Technical Committee detects an infringement of the class rules and requests the application of the corresponding Discretionary Penalties, these may be applied directly without hearing by the CDR (SP).

10. MEASUREMENT CONTROLS: All equipment and sails must be presented and will be identified with labels and/or stamps of the Championship in order to avoid unauthorized replacement of materials during the event.

11. NUMBER OF RACES AND SCORING SYSTEM:

11.1 For Classes 470 M/F - Finn - RS:X M/F - Standard Laser and Radial Femm. - 2.4 Mr - Hansa 303 - if possible 10 races will be held, with a maximum of 3 (three) races per day.

11.2 For the Nacra17 - 49er and 49erfx classes if possible 14 races will be held with a maximum of 4 (four) races per day.

11.3 For the Formula Kite Class, if possible, there will be 20 races with a maximum of 6 (six) races per day.

11.4 For iQFOIL Class if possible, there will be 16 races with a maximum of 5 (five) races per day.

11.5 An additional race might be held provided not to go ahead of the program for more than one race or to recover a test not carried out before.

11.6 The scoring system will be as per RRS 90.3 and Appendix A.

11.7 When less than 4 tests have been completed, the score of the championship of a boat will be equal to the score of all tests carried out. When a total of 4 or more tests have been completed, the score will be the total of the scores of the tests carried out discarding the worst result. For Classes 49er, 49erFX and Nacra17 a second discard will be applied at the completion of the ninth test, for Formula Kite the second discard applies from the 7 test, while a third discard from the 11 race.

11.8 For Classes RS:X Female, 470 Female and Mixed and Formula Kite if the start takes place with the male class, the ranking will be highlighted in the general one. Therefore if the first female competitor will arrive 5 (overall) she will be the first athlete in the Women's Classification but will have 5 points. The male ranking will not change.

11.9 As per FIV rules for the National Sport Organized in Italy 2020 - Point 5 Titles.

For the allocation of the title it will be necessary to have completed at least three valid races.

12. RACE FORMAT AND COURSES: The race will be run as specified in the "Rules for National Sports Activities Organized in Italy 2020 and their Class Cards". The courses will be defined in the SI.

13. SUPPORT PERSONS[DP] [NP]: All support persons must be accredited by completing the registration form available on the event website and sending it to the Secretariat of the event at the email address: regate@gvlnifollonica.it by 10 September writing in the object: "CICO2020, support person to....." and declaring:

1) the characteristics of the assistance boat;

2) acceptance of the "Rules for Support Persons boats" that will be described in the Sailing Instructions;

3) the names of the accompanied Competitors;

Support persons must be equipped with marine VHF radio and be tuned to the frequency of the assistance vessels, in case of emergency they will have to collaborate with the rescue boats and help boats in

distress. They will receive a flag, from the Regatta Secretariat, to be displayed on the vehicle (a deposit of 20 euros will be required for the flag).

Those who will be accredited after this date or who will not be accredited in advance will not be guaranteed mooring.

Accredited Support Persons will be subject to the technical and disciplinary directives of the CdR and the Jury who, in the event of infringement, may also revoke the permit to be present on the race course or act in accordance with RRS 64.4.

14. SAILING INSTRUCTIONS: The Sailing Instructions will be published on the official website of the event by 15 sep 2020 There will be no delivery of a hard copy of the SI, this changes the preamble to Appendix "L" of the RRS. All competitors or their Instructors must have communicated at the time of registration a telephone number and / or a mail to which all official communications of the event can be sent.

15. PREMI:

The following prizes will be awarded:

- Medals to the first three overall winners;
- Medals for the first three classified U 21 and U 24 (where required, see point 16 Notice);
- Medals for the first three women classified (where applicable, see point 16 Notice);
- Medals to the first three classified in the 470 Mixed Class
- Medals to the first three classified of the 2.4mR-PS Class
- Medal to the first classified female 2.4mR Class
- Medals for the top three in the Formula Kite male and female class;
- Medals to the first three classified of the Hansa 303 Class in single and double;
- Awards to the top three in the male and female iQFOiL Class.

16. ASSIGNMENT OF TITLES

17. RADIOCOMMUNICATIONS [DP] [NP]: A boat shall neither receive nor transmit radio communications that are not available to all competitors, except in emergency conditions or when using equipment made available by the OC. This restriction also applies to mobile phones, tablets and smartphones.

18. RESPONSABILITIES: As per fundamental rule 4, the participants in the regatta referred to in this Notice take part in it under their full and exclusive responsibility, the Competitors and their support people are solely responsible for the decision to take part or to continue the regatta. The Organizers, the CdR, the Jury and all those who collaborate in the running of the event, decline any and all responsibility for damages that people and / or things may suffer, both on land and in water, as a result of their participation in the regatta referred to in this Notice of Race. It is the competence of the Competitors and their support people to decide on the basis of their abilities, the strength of the wind, the state of the sea, the meteorological forecasts and everything else that must be expected by a good sailor, whether to go out to sea and participate at the regatta, to continue it or to give up.

19. PHOTOGRAPHIC AND / OR TELEVISION RIGHTS: The Competitors grant full right and permission to the Organizing Committee to publish and/or broadcast through any media, any photograph or filmed footage of people or boats during the event, including but not limited to, television commercials and everything else that may be used for its own editorial or advertising purposes or for printed information.

20. OTHER INFORMATION: Logistic information relating to hotels, regatta logistics, road signs or collateral events, are published on the event website: www.regatedelgolfo.it and on the website www.federvela.it where this Notice of Race, the registration form and logistics information will be published.

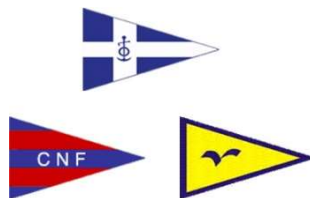
